



# Beautiful Fall Foliage in Door County

October 6-9, 2026

Join Jeanie's Journeys to The Cape Cod of the Midwest! Door County stretches from about 15 miles south of Sturgeon Bay to the islands that lie off the northern tip of the Door Peninsula. Wisconsin's most conspicuous feature extends like the spout of a teapot into Green Bay & Lake Michigan. Its rugged landscape dotted with fishing villages, beaches, farms & orchards resembles New England.

## DAY 1 | GREEN BAY - HOME OF THE PACKERS!

Depart Minneapolis with your Adventure Guide, Monica for Beautiful Door County! Today's travel will take you across Wisconsin while enjoying beautiful scenery along the way. You will drive to the top of Rib Mountain in Wausau for great views, then arrive at the home of the Green Bay Packers-Lambeau Field. After an included tour of this historic facility, enjoy an included dinner at Lambeau's on-site restaurant- 1919 Kitchen & Tap. Don't forget to wear your Viking purple (or green & gold if you are so inclined)! Then it's time to head to your local Green Bay hotel to turn in for the night. **Breakfast/Dinner**

## DAY 2 | DOOR COUNTY

Today you will head up into Door County, a place packed with fruit orchards, antique shops & picturesque fishing villages that line the coast. Tour throughout the peninsula, around the countryside, beside the orchards, and through some of the most beautiful Bay Villages. Visit Cave Point & Whitefish Dunes State Park. You will then enjoy lunch on your own at famous Al Johnson's Swedish Restaurant where the goats reside on the roof! After lunch, there will be time to wander some of the cute shops & boutiques in Sister Bay. Visit Door County's Seaquist Farm Market for a special visit. A stop at Bjorklunden Chapel, a small wooden church built in the 12th century Norwegian stave church style, will give you a real taste of Norwegian history. Then you will head to your resort to check in for the next 2 nights. The fish you will be feasting on this evening comes right in at the dock! You will then head back to your resort to relax for the rest of the night, but don't stay up too late, as you need to pack for home!
